- 20th largest economy globally with over \$1 Trillion GDP.
- Competitive edge: Business tax as low as 9%.

- Ranked highly safe: Safety Index of 71.45 (Numbeo).
- Low risk environment: Crime Index of only 28.55 and 0 global terror attacks.
